

**ORDINANCE NO. 120**

**AN ORDINANCE OF THE BOROUGH OF INDIAN LAKE,  
SOMERSET COUNTY, PENNSYLVANIA, AMENDING AND  
RESTATING ORDINANCE NO. 112 PERMITTING HUNTING  
OF CERTAIN TYPES OF GAME WITHIN THE BOROUGH  
LIMITS UNDER CERTAIN RULES AND REGULATIONS AS  
SET FORTH HEREIN.**

WHEREAS, the Borough Council of the Borough of Indian Lake, Somerset County, Pennsylvania finds that it is necessary and desirable to permit limited hunting of certain game within the Borough limits and that such hunting will promote the general welfare of the residents of the Borough;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Indian Lake, Somerset County, Pennsylvania, and it is hereby ENACTED and ORDAINED by authority of the same, as follows:

SECTION 1. Ordinance No. 112 of Indian Lake Borough, Somerset County, Pennsylvania, as hereby amended and restated as hereinafter set forth.

SECTION 2. The hunting of deer and wild geese within the Borough limits of the Borough of Indian Lake shall be permitted but only in accordance with the applicable statutes of the United States of America and the Commonwealth of Pennsylvania and the rules and regulations of the Pennsylvania Game Commission, as enacted and

promulgated from time to time, and in accordance with the following hunting rules and regulations of the Borough:

(a) All hunters must comply with the rules and regulations of the Pennsylvania Game Commission at all times. Violators will be prosecuted according to law.

(b) The hunting of geese in the Borough with shotguns shall be permitted, subject to applicable Federal and Pennsylvania statutes, the rules and regulations of the Pennsylvania Game Commission and these regulations.

(c) The hunting of deer with bow and arrow shall be permitted within the Borough limits, subject to the applicable Federal and Pennsylvania statutes, the rules and regulations of the Pennsylvania Game Commission and these regulations.

(d) Hunters of deer and geese within the Borough limits are required to pre-register at the Borough office, in person or by telephone, at which time each hunter must provide his or her name, address, telephone number, Pennsylvania hunting license number, a copy of each applicable hunting license and the license number of the vehicle which he or she will be using during the hunt. When registering to hunt, each hunter shall also designate those days when he or she intends to hunt within the Borough. Hunting shall only be permitted on a day to day basis.

(e) Hunters may only hunt in designated areas. Each hunter will receive a map showing such designated hunting areas at the time of registration.

(f) All deer killed by registered hunters must be gutted at the area designated for that purpose.

(g) Each hunter must register the number of geese and deer killed at the borough office at the end of each hunting day, either in person or by telephone.

(h) Baiting of deer and geese is prohibited and homeowners are prohibited from spreading corn or placing salt licks on their property in order to attract geese and deer.

(i) Hunters may use non-powered boats only to retrieve geese which fall into the lake. No powered boats may be used for such retrieval. Hunters may also use retrieval dogs to retrieve geese.

(j) Hunting within the Borough may only be done during the designated hunting seasons and times which are established by applicable Federal and Pennsylvania statutes and regulations.

SECTION 3. The rules and regulations set forth above in Section 2 of this Ordinance may be amended from time to time by the Borough Council.

SECTION 4. Any person who shall violate any of the provisions of this Ordinance or the hunting rules and regulations set forth herein shall, upon conviction thereof in a summary proceeding, be sentenced to pay a fine of not more than six hundred dollars (\$600.00) and the costs of prosecution and, in default of payment of such fine and costs, to be imprisoned for a period of not more than thirty (30) days.

SECTION 5. Any Ordinance or part of an Ordinance conflicting with the provisions of this Ordinance shall be and the same is here by repealed.

SECTION 6. This Ordinance shall take effect immediately upon final enactment.


