

ORDINANCE NO. 61

AN ORDINANCE AMENDING ORDINANCE NO. 59
OF THE BOROUGH OF INDIAN LAKE, SOMERSET COUNTY,
PENNSYLVANIA, REGULATING THE USE AND ENJOYMENT
FOR RECREATIONAL AND OTHER PURPOSES OF INDIAN
LAKE.

BE IT ORDAINED by the Council of the Borough of Indian
Lake, Somerset County, Pennsylvania, and it is hereby ORDAINED
by the authority of the same as follows:

The fourth sentence in Section 101 is replaced with the
following sentence:

". . .Beginning in the calendar year 1986 and
continuing thereafter, no jet ski, wet bike, wind
surfer type vessels or similar devices shall be permitted
to be operated upon the waters of Indian Lake. . ."

Subsection 102(c) is amended to read:

"After the licenses provided for in subsection
102(b) are issued, the Borough of Indian Lake shall, in
addition to the number of permits listed in subsection
102(a), have for issuance fifty (50) licenses which
shall be held for issuance to persons purchasing property
in the Borough of Indian Lake after the application
period provided in subsection 102(b) has closed who
desire a permit and who are unable to obtain one as
provided in subsection 102(f); house guests of Indian
Lake home owners as provided in subsection 102(l);
temporary licenses for persons renting or leasing
property from Indian Lake property owners as provided
by subsection 102(n); and yearly lessees who begin

their lease term after the application periods provided in this Ordinance have closed and who are unable to obtain a license under the provisions of subsection 102(n). The number of licenses retained by the Borough shall be subject to change by Resolution of the Borough Council of the Borough of Indian Lake. Any change shall be posted at the Borough Office. Persons purchasing property located in the Borough of Indian Lake shall be entitled to one (1) license at no charge under the provisions of this subsection. All others shall pay a fee as set by the Borough Council of the Borough of Indian Lake, which fee shall be subject to change and shall be posted at the Borough Office."

Subsection 102(k) is amended to read:

"The boat license must be displayed at all times on the left (port) side of the vessel adjacent to the Commonwealth of Pennsylvania boat permit."

There shall be added the following subsections:

"102(l). The property owner may obtain, under the provisions of subsection 102(c), a boat license for a vessel owned by a house guest of that property owner. For purposes of this Ordinance, the term 'house guest' shall mean a person invited by an Indian Lake property owner to visit the property owner at his property located in Indian Lake Borough for a day or one or more nights at no charge, but shall not include a person who permanently resides with the property owner."

"102(m). A person renting or leasing property from an Indian Lake property owner on a temporary basis may obtain a boat license under the provisions of subsection 102(c) upon the presentation to the Borough of Indian Lake of a rental receipt signed by the property owner. For purposes of this Ordinance, a person renting or leasing the property on a temporary basis shall mean a person who rents or leases property from an Indian Lake property owner for a short period of time, not exceeding four (4) consecutive months and who does not intend to make Indian Lake his permanent residence."

"102(n). A person who rents or leases property from an Indian Lake property owner (hereinafter landlord) for a period of time exceeding four (4) consecutive months (hereinafter yearly lessee) may obtain a boat license as follows:

(1) The landlord may transfer his license or licenses obtained under subsection 102(b) or (d) to the yearly lessee; or,

(2) If the landlord does not transfer a boat license or licenses to the yearly lessee under the provisions of 102(n)(1), then the yearly lessee may obtain a license under the provisions of 102(b) and/or (d) during the application periods for those licenses, provided there are licenses available for that lot under those subsections, or under subsection 102(e), if the landlord has obtained all the available licenses for that lot under the provisions of subsection 102(b) and (d)."

"102(o). All persons obtaining a boat license or licenses under the provisions of this Ordinance shall be subject to all the rules and regulations contained in this Ordinance or any amendments thereto."
