**RESOLUTION OF INDIAN LAKE BOROUGH,
SOMERSET COUNTY, PENNSYLVANIA
AMENDING SEWAGE APPLICATION RATES**

WHEREAS, the Borough of Indian Lake (hereinafter "Borough") had adopted Ordinance No. 60 and Ordinance No. 75 establishing a rate structure for applications for the consideration and issuance of sewage permits and related matters; and,

WHEREAS, the Borough desires to amend that rate structure; and,


WHEREAS, Section 1 of Ordinance No. 75 specifically allows modifications to the rate structure by Resolution:

2000 NON-PLANNING SEO FEE SCHEDULE

Description of Service:

1.	Application: Permit issued for new system, repair or alteration of system - Denied permit – Transfer permit to new property owner – Etc. May or may not include any one or all of the following: A. One site investigation & examination of maximum (8) soil Probes or (2) holes on site, whichever occurs first B. One standard (6) hole percolation test C. One standard system design review	\$270.00
2.	Site Investigation: Additional trip to site – No soil testing	\$ 60.00
3.	Soil Probes Examination: 1 st test area – Up to an additional (4) or (1) hour, Whichever occurs first. Simultaneous (SIM) with initial examinations	\$ 50.00
	Additional test area on same lot, (4) probes or (1) hour SIM with initial examinations	\$ 50.00
	Additional test area on same lot, (4) probes or (1) hour not SIM – Requiring extra trip to site	\$100.00
4.	Percolation Test: Standard (6) perc hole test area – Not SIM	\$150.00
	Additional (6) perc hole test area on same lot – SIM	\$ 50.00
	Larger than standard (6) perc hole test area, add to fees above Up to an additional (6) perc holes & conducted SIM	\$ 50.00
5.	Standard Design Review: Additional to one review included in application fee. If first review proves the design to be incorrect or incomplete, this same fee will be charged each time design is resubmitted. This fee should encourage more complete and accurate work being submitted for the applicant.	\$100.00
6.	Non-Standard Design Review: Not included in application fee. This is a minimum fee for up to (2) hours review. If first review proves the design to be incorrect or incomplete, this same fee will be charged each time design is resubmitted. Includes Individual Residential Spray Irrigation System, Drip Irrigation and other alternate & experimental systems, pressure distribution seepage beds greater than 2,500 Sq. Ft. and individually designed systems such as siphon & simultaneous dosing, etc.	\$100.00
7.	Construction Inspection: Per trip to site	\$ 60.00
8.	10 Acre Permit Exemption: Per trip to site	\$ 60.00
9.	Permit Revocation:	\$200.00
10.	Sewage System Dye Test & Report:	\$150.00

4.	Percolation Test: Standard (6) perc hole test area; 1st test area of lot	\$150.00

5.	Planning Module Review: 1st Lot	\$ 50.00
	Per lot after 1st lot	\$ 25.00
	If review proves the module to be incorrect or incomplete, these same fees will be charged each time module is resubmitted.	
6.	Planning Exemption Review: Per lot	\$ 10.00
7.	Design Review: Minimum fee for up to (2) hours review. For Planning Module approval it may be necessary to require a detailed design (possibly engineering design) to ensure that a test site is of sufficient area for absorption or spray. If first review proves the design to be incorrect or incomplete, this same fee will be charged each time design is resubmitted.	\$100.00
8.	Existing Septic System Inspection: Residual Tract or 1 st lot	\$ 60.00
	Per lot after 1 st lot – SIM	\$ 25.00
	Per lot after 1 st lot – Not SIM	\$ 60.00
9.	Sewage System Dye Test & Report	\$150.00
10.	Hourly Fee: Municipality – Will be charged for travel time	\$ 30.00
11.	Perc Test: Labor & Materials – May increase due to site accessibility. This service Is being offered only as an option and convenience to the developer and “does not” have any bearing on the test results.	\$160.00
