

ORDINANCE NO. 78

ORDINANCE AMENDING ORDINANCES NOS. 59, 67, 68, 71 AND 73 OF THE BOROUGH OF INDIAN LAKE, SOMERSET COUNTY, PENNSYLVANIA, REGULATING THE USE OF AND ENJOYMENT FOR RECREATIONAL AND OTHER PURPOSES OF INDIAN LAKE.

WHEREAS, Indian Lake Borough, has embarked upon a program to regulate the waters of Indian Lake; and,

WHEREAS, in accordance with that program, the Council of the Borough of Indian Lake deems it necessary to modify the issuance of temporary licenses to come onto the waters of Indian Lake Borough; and,

WHEREAS, said modification is the elimination of said temporary licenses;

NOW THEREFORE, BE IT ORDAINED, by the Council of the Borough of Indian Lake, Somerset County, Pennsylvania, and it is hereby ordained by the authority of the same as follows:

Article 1: Ordinances Nos. 59 and 61, Article I, Licensing and Regulation of Boating in General: Section 102, Boat Licenses, Subsection (1), which provides:

"102(1). The property owner may obtain, under the provisions of subsection 102(c), a boat license for a vessel owned by a house guest of that property owner. For purposes of this Ordinance, the term 'house guest' shall mean a person invited by an Indian Lake property

owner to visit the property owner at his property located in Indian Lake Borough for a day or one or more nights at no charge, but shall not include a person who permanently resides with the property owner."

is hereby repealed in its entirety.

Article 2: Ordinances Nos. 59 and 61, Article I, Licensing and Regulation of Boating in General: Section 102, Boat Licenses, Subsection (m), which provides:

"102(m). A person renting or leasing property from an Indian Lake property owner on a temporary basis may obtain a boat license under the provisions of subsection 102(c) upon the presentation to the Borough of Indian Lake of a rental receipt signed by the property owner. For purposes of this Ordinance, a person renting or leasing the property on a temporary basis shall mean a person who rents or leases property from an Indian Lake property owner for a short period of time, not exceeding four (4) consecutive months and who does not intend to make Indian Lake his permanent residence."

is hereby repealed in its entirety.

Article 3: Any other Ordinance or Ordinances or parts of an Ordinance or Ordinances inconsistent herewith are hereby repealed.

Article 4: This Ordinance shall be effective for all times after December 31, 1987.
