

ORDINANCE NO. 97

AN ORDINANCE OF THE BOROUGH OF INDIAN LAKE, SOMERSET COUNTY, PENNSYLVANIA, AMENDING THE ORDINANCE OF THE BOROUGH REGULATING THE USE AND ENJOYMENT FOR RECREATIONAL AND OTHER PURPOSES OF INDIAN LAKE

WHEREAS, the Borough of Indian Lake has by Ordinance No. 82, as amended, embarked upon a program of regulating the use and enjoyment for recreation and other purposes of Indian Lake; and,

WHEREAS, the Borough believes that it is in the best interest of the residents of the Borough and the community itself to modify the Ordinance, as amended;

NOW, THEREFORE, it is hereby ordained and enacted by the Borough Council of Indian Lake as follows:

ARTICLE ONE: ARTICLE I. LICENSING AND REGULATION OF BOATING IN GENERAL: Section 102. BOAT LICENSES: H. Term of License: is hereby amended to provide that the term of all licenses issued by the Borough shall coincide with the registration of boats as provided by the Commonwealth of Pennsylvania. Accordingly Subsection H shall read as follows: “H. Term of License: All licenses issued shall be valid for the current boating season and all licenses shall expire on the same date, to coincide with the term of registration for boats as provided by the Commonwealth of Pennsylvania, as amended, presently April 1 through March 31.”

ARTICLE TWO: ARTICLE I. LICENSING AND REGULATION OF BOATING IN GENERAL: Section 102. BOAT LICENSES: J. Establishment of Fees: is hereby amended to allow for the charging of fees for the issuance of primary boat licenses by the deletion of the last sentence of the paragraph.. Accordingly, Subsection J shall read as follows: “J. Establishment of Fees: All license fees shall be established by resolution of Borough Council and posted in the Borough office. All fees shall be paid by the Applicant before any license is issued.”

ARTICLE THREE: ARTICLE VI. MISCELLANEOUS: Section 601. LOT NUMBERS; MAINTENANCE OF DOCKS: is hereby amended to change the reference in the paragraph from "lot number" to "lake address". Accordingly, Section 601 shall read as follows: "Section 601. LOT NUMBERS; MAINTENANCE OF DOCKS: All dock and boat house owners on the perimeter of the lake and tributaries are required to display their lake address facing the lake, and to maintain docks and boat houses in safe repair and securely fastened. No boat shall be permitted on Indian Lake, and no licenses shall be issued therefor, if the boats are constructed with toilets or heads."

ARTICLE FOUR: ARTICLE VII. VIOLATIONS: Section 701. (a) PENALTIES; FINES: is hereby amended to provide that, to the extent that the violations set forth are the same as the violations as provided by the Commonwealth of Pennsylvania Fish Commission, the fine as provided by the Fish Commission, when applicable, should take precedence over the fine identified in the Ordinance. Accordingly, the following clause is added to the end of Section 701. (a) PENALTIES; FINES: as follows. "Provided, however, that the Commonwealth of Pennsylvania Fish Commission fines for violations, when applicable, shall take precedence over the aforesaid fines."


ARTICLE FIVE: RATIFICATION: In all other respects, Ordinance No. 82, as amended, is hereby ratified and reaffirmed.

ARTICLE SIX: EFFECTIVE DATE: This Ordinance shall be effective immediately upon its enactment by the Borough Council.




