WE DO NOT COMPLAIN ABOUT ALL THE TUBING ACTIVITIES, JET SKIING, SKIING ETC. WE MIND OUR OWN BUSINESS AND ALLOW OTHERS TO ENJOY THE LAKE AS THEY SEE FIT, EVEN THOUGH K THE WAKE FROM THIER ACTIVITIES IMPACTS US AS WELL. AL MY FISHING SPOTS AROUND THE LAKE ARE AS WONDERFULF ASS THEY WERE 20 YEARS AGO, IF NOT BETTER. THW WEED BEDS ARE THRIVING; THE ECOLOGH AND EXOSYSTEMS ARE THRIVING. WE ARE HOPEFUL THAT ALL VOICES ARE HEARDD EQUALLY ON THIS MATTER AND THAT THE COUNCIL PRESERVES THE RIGHTS OF ALL RESIDENCES AND MAINTAINS THE REPUTATION OF THE LAKE AS ONE THAT IS ""FUN FOR ALL"""

I HAVE SPOKEN AT SEVERAL COUNCIL MEETINGS THE PAST FEW YEARS SINCE THE TOPIC OF WAKE SURFING HAS BEEN BROUGHT UP AS AN ISSUE AT INDIAN LAKE. I ALSO WAS THE EMCEE AT THE INDIAN LAKE BOATING BONANZA A FEW YEAFS BACK. PLEASE DROP THE DRAMA AROUND WAKE SURFING + KEEP INDIAN LAKE A FAMILY FUN, HAPPY PLACE. YOUR ARE DIVIDING OUR COMMUNITY! THE UNSAFE PRACTICES I SEE ON THE LAKE ARE ONLY ON BUSY WEEKENDS AND ITS PONTOON BOATS W/ TUBERS-DRIVING IN SNAKE-LIKE PATTERNS+ JET SKIS TRYING TO GET AIER ON OTHER BOAT WAVES. WAKE SURFING IS NOT THE SAFETY ISSURE AT OUR LAKE. I ENCOURAGE COUNCIL TO CONTINUE BOAT SAFETY EDUCATION+ STOP ADDING MORE+ MORE RULES THAT WE HAVEN'T HAD FOR 60+ YEARS. LAST SUMMER, A PROMINENT INDIAN LAKE RESIDENT GAVE ME+ MY FAMILY W KIDS THE "ITALIAN SALUTE"- I REACHED OUT TO HIM AFTERWARDS+ HE JUSTIFIED HIS ACTIONS BECAUSE WE WERE SURFING. THIS IS THE TYPE OF RIFT YOU'RE CREATINGA AT INDIAN LAKE. STOP. ALSO, THIS SURVEY IS A WASTE OF INDIAN LAKE DOLLARS-IT SHOULD HAVE BEEN ON LINE FOR EASY TABULATION, TRULY AMONG NOWS + **QUESTIONS WRITTREN BY A 3RD PARTY. THE AGENDA IS VERY CLEAR HERE. DISAPPOINTED!** 

"I UNDERSTAND THE ISSUES, PARTICULARLY FOR A SMALL LAKE SUCH AS OURS. I AM ALSO AWARE THAT THERE ARE TENSIONS & DIVISIONS AS THESE ISSUES AER REVIEWED. MY HOPE & ASSUMPTION IS THAT CHANGES WILL NOT HAPPEN TO THE RESIDENTS - BUT WITH THEM.

THERE HAS TO BE GIVE & TAKE AND AN OVER-RIDING COMMITMENT TO CALMLY NEGOTIATED SETTLEMENTS.

KINDNESS, PATIENCE & AN ABSOLUTE COMMITMENT TO COMMUNITY MUST DRIVE ALL DECISSIONS. OUR NATIONAL POLITICS ARE DIVISEVE. I, LIKE ALL IL RESIDENTS, HOPE WE CAN RESOLVE ISSUES WITH MUTUAL RESPECT SO AS NOT TO ALLOW A MICROCOSIM OF OUR NATIONAL POLITICS TO TAKE HOLD AT THE LAKE."

Shoreline at our family house at Navajo greatly eroding much faster in the last 5-7 years due to larger boats versus 1968 2012-2015 timeline. Less courtesy from other boaters (newer folks to the lake) who feel entitled to enjoy their activity on the water without regard to how their activities impact others. Jet ski speed out of control as they become super-charged. Re-instate the hp limit. I have sail-boated in the winter but de-icers virtually prohibiting that type of boating in the winter

I do think changes are necessary, not only for continued enjoyment of the lake but mainly for safety reasons. "

Make the minimum for PWC 16 and a drivers license. A 12 year old has no business on a 300 hp PWC, especially on such a small lake.

I SUPPORT EDUCATION AND BETTER ENFORSEMENT OF CURRANT RULES/REGULATIONS

I DO NOT SUPPORT INCREASED RULE/RTEGULATIONS"

I'M NOT REALY SURE WHY THERE ARE SO MANY COMPLAINTS ABOUT BOATING. THERE ARE TRULY ONLY 3 MAJOR HOLIDAYS IN THE SUMMER SEASON. MANY SATURDAYS AND SUNDAYS HAVE FEW BOATS OUT. FOLKS JUST NEED TO BE AWARE OF BOAT SAFETY AND EDEQUETTE. MANY FOLKS MADE INVESTMENTS IN MULTIPLE WATER CRAFT AND CAN'T USE THEM. I'VE INVESTED IN A WAVE RUNNER AND DOCK(FLOATING) AND PAID FOR THE GENERAL PASS FOR YEARS. NOW DUE TO RULE CHANGES WE CAN'T USE IT THIS YEAR. I SAW WHERE IT WAS SUGGESTED THAT FOLKS PAY \$750 FOR 2ND BOAT. SO THERE MUST BE A LOSS OF REVENUE. NO ONE CAN HAVE ALL WATERCRAFT OUT AT ONE TIME. I'D LIKE TO SEE THE GENERAL PASS HOLDERS RESTORED.D INDIAN LAKED REAL ESTATE AGENT SOLD US THAT EVERYONE GETS ALONG- NO ISSUES WITH BOATING. ALWAYS S OMETHING ANYMORE. BUT THANK YOU TO THE COMMITTEEDS- IF ITS NOT EASY BEING A REPRESENTATIVE.

Wake boats are annoying but I have not experienced any real damage or safety issues. Proper lakefront construction will stop erosion issues. Large blocks work well, riprap is cheap and easy to maintain. Most boats if well docked an secured will experience minimal damage. Cantilevered docks are not immune to ice damage. New docks that are apparently built to secure great lake freighters. Conclusion, if you want to protect your boat and property, 1) build a proper lakefront 2) build a proper dock 3) secure boat properly 4) five to six times a year sit under a tree and laugh at morons. If you want to cry and complain instead then expect the borough to fix the world for you.

As stated, problems on the lake are minimal. Please use a very light touch to fix your perceived problem... not a sledge hammer!

Thank you for sending this to me. It has been several years since I have been at the lake. I own an unimproved lot in a wooded area. Years ago I brought my young adult sons to the lot, we were approached by some law enforcement people who asked who owned the lot. I was there and able to intervene and say "I did" so they allowed us to stay. They had a small bonfire and some friends and food. They wanted to spend the night, and they were permitted for one time. Now I attempted to rent to bring my Mom to visit the lot where we had fun as a family. We weren't allowed to do that either. We have no boat- haven't since the early 70's, and we live in Maryland now. We don't come to the lake anymore because logistically it doesn't work. Great memories, but prohibitive today. I have a 24 ft. RV that I would bring for a weekend if I could. It's a bit sad. On a more objective note, I don't have anything else to add to the survey so I'll just not get involved. Do the right thing, I don't know! Please don't make it difficult for others to enjoy a beautiful place.

This survey is clearly biased seeking an outcome designed to limit recreation on the lake. The Pa. boating laws should be sufficient.

Boat safety crawl event. I have had a printers business, I would be happy to provide discounted printing if needed.

We have owned our house for one year. My family has owned a house and I have been coming to the lake for 30 years before we purchased our own.

ALL FAMILY MEMBERS HAVE BOAT LICENSES. ENFORCE RULES. MORE PRESENCE ON LAKE DURING BUSY BOATING TIMES.

#### "Think:

When a tree falls in the forest and no one is there does it make a sound? Likewise/when a wake boat plows and creates a huge wave below the surface and no one sees it, does the unseen wave energy damage the lakes eco system? We need to evaluate ourselves about the eye opening effect of wake boats. I am not against wake boats or wake surfing. Our lake

HOWEVER BECAUSE OF THIS NEW RULE, 1 JET SKI AND PONTOON HAVE TO GO OUT TOGETHER. INDIAN LAKE HAS BEVCOME TO WOKE!!!

THE BOATING COMMITTEE SEEMS TO BE IN SEARCH OF A PROBLEM THAT DOES NOT REALY EXIST. IVE BOATED ON PUBLIC RIVERS AN LAKES BEFORE AN WEEKENDS & HOLIDAYS. INDIAN LAKE DOES NOT HAVE A PROBLEM!

I understand the borough councils concern for safety, however, I do feel that some of the concerns brought to council are being overblown. I feel safer on the water than I feel driving on the turnpike to get to the lake.

I appreciate everyone that volunteers and spends time addressing issues and asking hard questions. My family has been coming to the lake for over 30 years. We love it. Please don't try to fix things that are not broken. Let everyone that pays taxes have representation and a voice, not just the people that live in Indian Lake borough year round. There is no reason to reduce the number of boat licences. Nobody is takiong 3 boats at the same time. you're taking away peoples freedom one ordinance at a time. Relax.

OUR BOAT SITS ON A MECHANICAL LIFT WHEN THE BOAT ISN'T BEING USED. WE ARRIVED AT THE LAKE ON A FRIDY EVENING TO FIN A PORTION OF THE BOAT SITTING IN THE WATER. AFTER FURTHER INVESTIGATION THE CRADLE WAS BENT ALONG WITH THE FRAMEWORK OPF THE LIFT. ATTACHED ARE TWO PICTURES OF THE DAMAGE. THE DAMAGE WERE CAUSED BY A WAVE.

WE HAVE MADE AN ADJUSTMENT TO LIFT THE BOAT HIGHER OUT OPF THE WATER SO WAVES CAN NO LONGER CAUSE THE DAMAGE. SINCE PA IS A STATE THAT HOLD BOAT OWNERS ACCOUNTABLE FOR THE DAMAGE THEY CAUSE BY THEIR WAKE WE HAVE INSTALLED CAMERAS."

It would be helpful to our family if additional docks were added to the marina. We have been on a waiting list to rent a dock for 4 years.

I WOULD CONSIDER SIGNIFICANTILY LIMITING MY MOTORIZED BOAT USE TO IMPROVE THE OVERALL LAKE EXPERIENCE

I have a problem with the wave runners speeding constantly.

LIMIT HORSE POWER

This should have been designed to be completely anonymous.

"TOO MANY RULES WILL ALWAYS HAVE TO BE PUT IN PLACE BECAUSE THE MORE POWERED BOATS THAT ARE ON THE LAKE WILL GENERATE MORE RULES BECAUSE THE LAKE WILL BECOME MOERE UNSAFE. THE ENVIRONMENT WILL BE IMPACTED.

"WALKE BOATS ARE GETTING A BAD RAP.

THIS IS ONLY DONE WHEN PULLING A SURFER

THEY ARE PULLED AT A SPEED OF 9-10 MPH

WHEN THIS IS DONE YOU ARE GOING THRU TWICE THE AMOUNT OF FUEL THAN NORMAL. SO VIRTUALLY YOU NEVER DO IT. ESPECIALLY WHEN FUEL AT MARINA IS OVER \$5 PER GALLON. ALL BOATS CREATE WAKE & NOT JUST WAKE BOATS."

Being a long term homeowner, you see all the changes that have occurred over the years. The lake is amazing and I hope it continues to remain that way. Some "new" boat owners/homeowners are not aware of the lake rules and it is scary sometimes. These people should really learn the ways of the lake before using it.

Too many new regulations being considered. Just need people to be more respectful of each other.

50 YEARS AGO WHEN THE LAKE WAS ESTABLISHED, BOARS AND ENGINES WERE MUCH SMALLER AND THEIR IMPACT ON THE LAKE IN GENERAL WAS MUCH LESS."

WHILE I SIT ON MY DOCK FROM 6;30 AM -9:00AM SATURDAY AND SUNDAY AS A COURTESY TO SKIERS, LATELY I HAVE BEEN VERY FLUSTRATED WITH SKIERS BEING OUT FROM 9-11 AM ME BEING A SURFER AND A SKIER COME BY GUY MAKES ME CIRCLE BACK AND CAUSE MORE WAKE FOR ALL OF US. WHILE, AS A SLALOM SKIER MYSERLF, PARTICUARLY WHEN YOUNGER, I KNEW THE GOOD WATER WAS IN THE EARLY MORNING ONLY.

TUBING IS A HUGE SEFETY CONCERN AND WAKE MAKER FOR SOME REASON IT RARELY ADDRESSED BY THE COUNCIL AND BOATING COMMITTEE LIKELY BECAUSE MEMBERS ACRTIVELY ENGAGE IN THE ACTIVITY.

THE LAKE IS AN AMAZING PLACE WITH A GREAT COMMUNITY. I FEEL ADDITIOINAL REGULATIONS ARE UNNECESSARY AND CONTINUE TO FRACTURE NEIGHBORS RELATIONSHIPS. PLEASE JUST STOP ALL OF THIS NON-SENSE. "

"Thank you for making the coves no wake this season. This has helped so much. A suggestion: could the area coming out of the marina and in front of the launch ramp be no wake. When a wake boat/bow rider comes out of the marina they immediately speed up with no regard to any boaters who may be coming into the launch ramp or the boat docks.

In addition, sometimes they cut completely in front of boats trying to access those places.

Lake creator and visionary, Jim McIntyre, told me personally circa 1969 the lake was created to enjoy powered water sports. We should maintain this standard as many other lakes have lost this vision.

Having lived in Comanche park off west shore road for over 20 years the recent designation of our cove as a no wake zone has created excessive traffic. Peak time boat mooring, swimming, and partying blocks access to our properties. Many weekends several owners cannot access our docks and lifts due to the closeness of partying boats moored. No wake buoys seem to mean park here, swim, party, block cove access. Example recent 4th of July holiday not once did IL patrols or Pa fish enter our cove to see the illegal activities.

## **GENERAL COMMENT:**

ASIDE FROM SECTION 1 AND 2 PROVIDING DEMOGRAPHICS TYPE DATA, THE REMAINDER OF THE SUREY SI SUBJECTIVE AND OPINION BASED. THE SUREY SEEMS TO BE NOTHING MORE THAN A TOOL TO HARVEST BIASED OPINIONS TO FURTHER A MINORITY AGENDA ON THE LAKE. IT IS A HUGE DISAPOINTMENT BECAUSE IT COULD HAVVE BEEN DONE SO MUCH BETTER IF SOMEONE WITH RESEARCH OR STATICIAL EXPERIENCE WOULD HAVE BEEN INCLUDED ON THE TEAM."

Please enforce rules and have a stronger presence on the water. Only issues are on weekends and holidays. Sail boat comments and restrictions are baseless and should be removed from any rule. All boats should be measured before a license is given. Several boat owners in the past may have given incorrect numbers and should not be grandfathered due to the information given.

"WE ARE WRITING TO EXPRESS OUR CONCERN ABOUT THE INCREASING SAFETY ON INDIAN LAKE DUE TO LARGE WAKES CREATED BY WAKE BOATS.

OVER THE FOURTH OF JULY WEEKEND, WE WERE OUT ON THE LAKE WITH OUR PONTOON BOAT WHEN A WAKE BOAT PASSED NEARBY AT WHAT APPEARED TO BE A SAFE DISTANCE. THE WAVE GENERATED WAS SO LARGE THAT WATER CAME OVER THE FRONT OF OUR PONTOON. THE FLOOR OF THE BOAT WAS FLOODED FROM FRONT TO STERN. EVEN MORE CONCERNING, THE BOAT DIRECTLY BEHIND US, A 22' IO RUNABOUT WAS HIT BY THE SAME WAVE. THE GENERATED WAVE CAUSED THE FRONT OF THE VESSEL TO DIP UNDER RTHE WATER. THIS WAS FRIGHTENING AND DANGEROUS SITUATION THAT COULD HAVE RESULTED IN SERIOUS INJURY OR DAMAGE. THIS IS NOT THE FIRST TIME THIS HAS HAPPENED. WITH THE UNDERSTANDING THAT THE 4TH OF JULY WEEKEND IS A BUSY WEEKEND ON THE LAKE, THIS SAME SITUATION HAS OCCURED ON LESS BUSY WEEKENDS AS WELL.

WE FULLY UNDERSTAND AND RESPECT THAT THERE ARE ALREADY WAKE BOATS ON THE LAKE, AND MANY RESIDENTS ENJOY THEIR USE. HOWEVER, WE BELIEVE THAT THE CURRENT SITUATION MAY REQUIRE RETHINKING HOW THESE BOATS INTERACT WITH THE REST OF THE COMMUNITY, ESPECIALLY GIVEN THE SIZE OF INDIAN LAKE AND THE VERIETY OF USERS IT SERVES. IN ADDITION TO THE DANGERS ON THE WATER, WE ALSO NOTICED THE NEGATIVE EFFECTS OF THESE LARGE WAKES ON OUR DOCKS. AS WE ATTEMPT TO DOCK, THE WAVES FROM THESE TYPE OF BOATS CAUSE THE FLOATING DOCK TO MOVE UP AND DOWN. IT IS OFTEN DIFFICULT AND UNSAFE TO APPROACH. THE EXCESSIVE WAVES ON THIS SMALL LAKE CAN ALSO CAUSE EROSION ALONG THE SHORELINE, FURTHER IMPACTING THE LAKE'S INTEGRITY.

THESE LARGE, ARTIFICIAL WAKES ARE NOT ONLY DISRUPTIVE, BUT THEY ALSO POSE A REAL SAFETY HAZARD, ESPECIALLY FOR SMALLER OR SLOWERE-MOVING BOATS, KAYAKS, PADDLEBOARDS, SWIMMERS, AND EVEN THOSE TRYING TO DOCK SAFELY. INDIAN LAKE IS A SMALL, RESIDENTIAL LAKE NOT DESIGNED TO SAFELY ACCOMIDODATE THE KIND OF WATER DISPLACEMENT CREATED BY WAKE BOATS.

We have owned property in the narrows for 25 years and seen many changes on the lake. We enjoy seeing others boating and enjoying activities in the lake. We love the upgrade the marina offers (ice cream and bar). We did notice a significant change in the number of boats in the 20-21 season due to COVID. However, since COVID this is no longer the case. The number of boats/watercraft on the water in the past 2-3 years has significantly decreased. It is frustrating that the borough is now trying to implement new ordinances and restrictions when there is no longer a problem with excessive boat traffic. We strongly feel that boat traffic has decreased to pre-pandemic levels. In fact, July 4 weekend 2025 we saw fewer boats today than we saw 10 years ago on the same weekend. We see very few boats pulled over by patrols because people are simply following the rules. We hope the borough recognizes the overall decrease in boating activity from pandemic levels. Imposing restrictions sends a message that the borough listens to the very few and not the majority who own property and pay taxes.

"No further ordinances should be issued by council. Guidelines set by Pa. fish commission along with courtesy, respect and being aware of others on the water should suffice. If there are areas of concern to council they could be addressed in a more honest and forthright method and steps, all lake owners should have a say and their ideas valued. The voices of many have spoken against personal agendas.

If your desire to reduce pontoon size would essentially put more boats on the water. Having large families will encourage 2 boats to go out on the water, since not all can fit the required weight/number limit on 1 boat.

All existing boats should be grandfathered for the life of the boat, irregardless of changes that council wants to try and set. All persons made a large investments in the present existing boats. When a new boat is purchased then a new guideline will be in effect. That is the honest and right way to show respect to the community and peoples financial investment."

People need educated on what 100ft from shore/docks looks like. Two out of 3 boats that go by our dock in the narrows is within 100 ft and usually within 50 ft. and they are making a wake. There are good resources out there (pamphlet, video, etc.) but people aren't looking at it. They need to be warned by the police of fish commission in order to understand. I have already sent a letter to council with my concerns.

Been a part time resident for almost 50 yrs. I remember when we had no police and didn't need any. You lost control many years ago. Thank you for sending non-voting property owners this survey. Our opinions are usually ignored.

More police coverage during peak periods

In general, people pulling tubers seem to follow the flow of lake traffic and give spacing. Jet skis zoom around tubing boats which also can be the cause of boating safety concerns. During the weekdays there is no issue with crowding and generally no issues as space helps keep boats away.

Please protect are lake, Mr. McIntyre didn't intent to have 700hp wake boats on this lake. When the original change was made to H.P. the peoples argument for the change was the inboard boats they go slow and there is no wake. I sure don't think the board would ever imagined where we have come from that original change.

## "Police:

Patrol boat should be on the lake every weekend. Not really needed on Tuesday when there are 3 boats out. They can just sit on the lake! Police presence encourages better driving. We are not asking for police to be more heavy handed. First offense warning, if people choose to be repeat offenders, break out the fines.

Wake boats: It has become increasingly apparent that they are causing more damage to the shore line. We are not looking to take away anyone's rights, but placing a cap on the growing number of said boats seems reasonable. Suggestion, maybe have a rule that boats empty their ballasts when they are not towing anyone.

Last weekend a large brown pontoon was speeding just past the townhouses towards the marina coming hard on clockwise into traffic. I have to assume that the driver is not familiar with lake protocols. That's where we can continue to improve. Homeowners have to be vigilant with their boats and guests. Thank you for attempting to improve our lake and policies, but please consider modest general consensus type changes. ALL homeowners should have a vote in these matters, not just full time residents.

The problem at the lake is not the wake boats. The problem is the borough trying to change the rules/laws every year. Just let people enjoy the lake how they see fit. Mine and family's safety is not the responsibility of the borough. It is my responsibility. If there are unsafe conditions on the lake, it is my judgement not to take my family out, which never happens. We are out on the lake even during busy holiday weekends, and I have 3 young kids.
